ASUU Constitution Article I.IV-College Student Councils

1. Membership

- 1.1. The College Student Council within each College will consist of the designees from each department within the College, at least one (1) appointee of the Dean of the College, the Assembly Representatives of the College, and the Student Senator from the College.
 - 1.1.1. The designees of each department may be chosen in any manner deemed fit by the College.
 - 1.1.2. The term of the College Student Council will be co-terminus with that of the Assembly and Student Senate.
 - 1.1.3. The Student Senator will chair the College Student Council.

2. Powers and Duties

- 2.1. To promote the academic development of its College's student body.
- 2.2. To perform student evaluations.
- 2.3. To engage in Retention, Promotion, and Tenure (RPT) processes.
- 2.4. To participate in Tenure Faculty Review.
- 2.5. To propose legislation to the Student Senate.
- 2.6. To review travel applications for all students and sponsored student organizations affiliated with the College.
 - 2.6.1. All approved travel applications will be forwarded to the ASUU Travel Committee.
- 2.7. To provide a forum for members of each College to discuss academic matters and other appropriate concerns with the members of the College Student Council.
- 2.8. To meet at least two (2) times per semester

Recognized Student Organization Classification*

"Recognized student organizations" as used in this rule shall refer to all student groups who register with, and receive recognition from ASUU. The term recognized student organizations does not include ASUU government or any University departments with student-led initiatives and outreach programs that do not seek recognition with ASUU and are functions of the University department. The recognized student organization must select their own leadership and they must not be compensated for their involvement.

College Student Council Registration & Funding

To receive the benefits of recognized student organizations, College Student Councils must register with ASUU annually through the ASUU website. Required information at the time of registering includes names of three officers and an advisor. College Student Councils are not required to have a constitution due to the fact that their purpose is outlined within the ASUU Constitution and Bylaws. The registration and annual renewal is the same place in which the College Student Council portal is maintained throughout the year, which also includes a listing of the members, other identified administrators, and requests for funding from both the Student Senate and the Travel Fund.

The \$8,000 Funding Cap includes Student Senate and Travel Fund allocations.
